- (b) the grant to directors and employees of, and consultants to, the Company of options over equity securities up to an aggregate nominal amount of £200,000.00; and

(c) the allotment (otherwise than pursuant to sub-paragraphs (a) and (b) above) of equity securities up to an aggregate nominal amount of £728,959.38,
